Chair Bell called the meeting to order and Commissioner Williams gave the invocation. There were no **Committee Reports** or **Visitors** requesting an audience with the Board.

Mr. McCrory extended warm wishes and congratulations to **MR. TAM P. VO**, Treatment Plant Operator II, on his retirement after 13 years of service.

Chair Bell presented the **Consent Agenda Items** for approval, and they are as follows:

Commissioner Zoghby moved for approval of the **Consent Agenda**. Commissioner Drummond seconded and the motion then carried with the unanimous vote of the Board present.

Mr. Cote approached the Board to review a **presentation** of the **SCADA** program. Supervisory Control **And D**ata **A**cquisition is the computer systems that provide operators with a dashboard for monitoring and in some cases controlling industrial processes at both local and remote sites. There are nineteen radio frequencies dedicated to MAWSS by the Federal Communications Commission at no annual cost.

MAWSS utilizes SCADA at the following locations:

- Water and Wastewater Treatment Plants
- · Water Booster Stations in the Distribution System
- Lift Stations in Wastewater Collection and Transmission Systems
- Three Mile Creek and Eslava Creek SWATs
- Park Forest
- Emergency Operations Center

Physical Phenomenon is remotely measured by a sensor or instrument that produces an output signal to detect a physical phenomenon. An example of a simple discrete sensor is a switch indicating whether a door is open or closed. A more complex sensor will condition electrical currents so that its output in 4-20 mA is related to the physical phenomenon. A pressure sensor in a lift station wet well is an example. As the depth in the wet well increases, the output amperage increases.

Voltage is sent to the sensor and receives output from a Remote Terminal Unit (RTU) which is a micro-processor controlled device that interfaces objects in the physical world to a SCADA system by transmitting telemetry data to a master supervisory system to control or view the status of connected objects.

The type of data MAWSS is able to capture with SCADA at a typical two-pump lift station includes; general alarms, motor switches, over temperature alarms, pump on / off alarms, door open alarms, unathorized entry notifications, power failure, flows at stations, etc.

Mediums utilitized by our operators to receive this information from remote locations are:

- UHF Radio Over MAWSS Designated Frequency by FCC (Remote Location to Building/Site)
- Microwave Radio (Building to Building/Site to Site)
- Fiber Optics (Building to Building/Site to Site)
- Cell Technology(Building to Building/Building to Laptop)

There are many advantages to SCADA, including reporting features, color code alarms, and polling abilities. Mr. Cote concluded his presentation with an overview of SCADA project schedules, costs and VT SCADA Software costs.
